### **III Approval of Minutes**

A motion was made to accept the meeting minutes, from the December 21, 2020 meeting, without changes.

Allen Green made the motion and Mike Houtte made the second.

### **IV Discussion: November Financials and December Update**

The board discussed the November financials, with expenses at \$51611, and better than budget by \$21000 for the month. Net Cash Flow for the 2020 YTD Actuals was approximately \$238,390. The December update had \$3995 in merchandise sales and approximately \$5000 in gift card sales.

### **V Discussion: Clubhouse Design Update**

The board discussed the status of the engineering drawings necessary for inclusion in the bid documents. Bidder documents are expected to be sent out in mid-February, with contractor responses expected 3 weeks later. The estimated cost for the remodel project is \$760,000, which includes a 15% contingency, and includes funding for FFE (Furniture, fixtures, and equipment) and kitchen improvements. President Dodd has asked commissioner Houtte and or commissioner Vermeire to provide an update to the ADLC commissioners on the clubhouse remodel project.

### **VI Off Season Update**

Merchandise Sales at the Christmas Open House had limited success, given the COVID-19 pandemic. The original plan was to serve food and refreshments to attendees during the event but was deferred until the pandemic has passed.

Tournaments and Events the Veteran Assn has booked a tournament for Monday, Aug 2 at Old Works. The State Seniors tournament is also scheduled for this summer.

Marketing The online store will be operational on January 5, 2021, which will also be marketing thru Facebook, email, and the local newspapers. Passholders are now able to purchase passes until March 31, 2021 at a 10% discount, and local (Anaconda Deer Lodge county) residents will also qualify for an additional 10% discount.
