IV Discussion: Status of Opening Golf Course, Restaurant, Bar

The board discussed various repairs needed at the golf course to include entry doors, kitchen equipment, course irrigation and ball washing equipment.

Under new business, Gary Carlson discussed refunds, but given the weather conditions agreed that no refunds were warranted.

Under miscellaneous, Adam Pohll requested permission to proceed with advertising the opening of the golf course in other markets. The board agreed, and granted permission to begin marketing.
