3.II. CLG 2023-2024 Grant
Project funds (\$2,000)

Gayla reached out to 3 consultants about documenting properties in the Northern Addition. One bid was received from Rossillon Consulting to inventory 5 properties found to be potentially eligible to the National Register for \$1,919. General prices estimates were provided by Delia Hagen: ~\$1,000 per inventory, \$7,500- \$10,000+ for nominations, and \$50,000+ for Multiple Property Documentation. The third consultant did not return a message.

Gayla explained the property inventories would be a good start where next steps could include nominating individual properties or further exploring a district. A recent example was shared for 516 Spruce Street, <https://www.adlc.us/DocumentCenter/View/3932/24DL0822-516-Spruce-Street>.

Bob asked if documentation would be provided for each of the 5 properties. Mary Lynn thought it was a good price for all 5. Gayla asked for the board to consider folks who could help with researching the families and their stories. Rose said that many families are still in town.

Lynette Foulger motioned to approve the bid from Rossillon Consulting. Terry LaValley seconded, and the motion carried 5-0.
