Set up, maintenance, and removal of handicapped signs and curb painting is the responsibility of the applicant. No sign shall be posted on trees, fences, or county property. Curb painting begins at face of sign and extends only 20 ft back from the sign. Handicapped Parking Space Permits are only valid for one (1) year from the date of issuance. Handicapped Parking Space Permits will not be issued on a temporary basis. Handicapped Parking Space Permits will only be issued for individuals who have a current driver's license and currently own and operate a personal vehicle. The issuance of a Handicapped Parking Space Permit and signs does not constitute a private parking spot for that property owner. Any person with a current and valid handicapped parking placard or plates may park in any designated Handicapped Parking Space.
